Volunteer understands that the scope of Volunteer's relationship with the International Student Mentor Program through Washington College is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that Washington College will not provide any benefits traditionally associated with employment to Volunteer; that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to Washington College; and that Volunteer is responsible for ensuring his/her own homeowners and auto insurance policies cover guests and visitors in the event of injury to the international student mentee or others.

- 1. Waiver and Release: In consideration of the opportunity to participate in the International Student Mentor Program as a volunteer, I, the Volunteer, release and forever discharge and hold harmless Washington College and its directors, officers, employees, agents, successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Washington College. I understand and acknowledge that this Release discharges Washington College from any liability or claim that I may have against Washington College with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Washington College or occurring while I am providing volunteer services.
- 2. Insurance: Further I understand that Washington College does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, auto, home owners, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Washington College.
- 3. Medical Treatment: I hereby Release and forever discharge Washington College from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or

other medical services rendered in connection with an emergency related to my service as a volunteer with Washington College.

- 4. Assumption of Risk: I understand that the services I provide to Washington College may include activities that may be hazardous to me. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release Washington College from all liability.
- 5. Photographic Release: I grant and convey to Washington College all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Washington College in connection with my providing volunteer services to Washington College.
- 6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Maryland and that this Release shall be governed by and interpreted in accordance with the laws of the State of Maryland. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
