\_\_\_\_\_ I understand that if any roommate decides not to return to Washington College or for any reason refuses to accept the assigned apartment, and the remaining roommates cannot fill the vacancy within two (2) business days, the Residential Life Office will assign a new student to the apartment.

\_\_\_\_\_ I understand that Kent Crossing Apartments are smoke-free. Smoking can only occur in areas where smoke cannot enter any apartment. Smoking from balconies, stairwells, etc. is prohibited.
